

24/7 Access Terms & Conditions of Waukon Wellness Center

1. **Availability/Age Requirements:** 24/7 access available for purchase with all **memberships** and **punch cards**, allowing access into Waukon Wellness Center 24 hours a day and 7 days a week, including holidays and inclement weather.

Cards belonging to persons **17 and under** (see "**Exception**" below) will **not unlock the door** without a valid adult card accessing at the same time.

**** Exception:** If a parent verbally gives consent to a Waukon Wellness Center employee for their child age 16 or 17 to utilize after-hour access without an adult, the child may do so, BUT the child will **ONLY** be allowed to bring in **immediate** family members as guests.

There must be 1 adult present for every 4 youth.

2. **Who needs a card:** A 24/7 access card **must** be purchased for **EACH person on a membership and/or EACH person using a Punch Card** to be allowed access into Waukon Wellness Center after regular hours.
3. **Cost:** \$25.00 for the first card purchased per membership and \$10.00 for every additional card. This is a one-time fee unless lost or stolen. (For example: Mom buys card for \$25.00, Dad buys card for \$10.00, Son buys card for \$10.00). **This is a one-time fee.**
4. **Lost or stolen card:** A \$10.00 fee will be charged to cancel your card and to replace it with a new card. It is **imperative** that you notify the WWC if your card is lost or stolen. You will be held accountable for any damages that occur until your card is cancelled.
5. **Accessible Areas:** 24/7 cards give you access **only** to the Wellness Center, **excluding the Cycling Studio and Rock Wall**. No access is granted to the **Senior Center, NICC classrooms, or offices housed in the Wellness Center or NICC**.
6. **When to use card:** Outside of normal business hours **ONLY**; during normal business hours, check in at service desk as usual.
7. **Guests:** Welcome – **responsibility of person owning 24/7 card** to **1)** pay appropriate fee for all guests (deposit into metal box on counter), **2)** supervise all guests, and **3)** be **certain all guests have left the Center before or with person owning 24/7 card**.
8. **Surveillance:** Cameras monitor the Wellness Center 24 hours a day, 7 days/week, 365 days/year.
9. **Emergency:** Use phone to call 9-1-1.

Penalty for Non-Compliance: If you are found not following **all** terms and conditions **and/or** sharing your access card with other individuals **and/or** allowing youth 17 years of age and under to access Wellness Center **with your card**, we will immediately limit or cancel your 24/7 access!
